

PRIVACY POLICY

According to the General Data Protection Regulation (UE) 2016/679, Privacy Code and following integrations and changes, the following is made known:

a) The personal data You deliberately provide, when compiling the registration module to formulate the request for information on products, services, marketing promotions, events and promotional initiatives of the company, will be subject to handling, including via the use of information technology and telematics procedures on Data-Base, for the following reasons: Management, statistical, commercial, promotional and advertising uses, related to the products and services of Marloc S.r.l.

e) In relation to the aforementioned handling, the subject of reference of the personal data has, at any time, the right to obtain confirmation of whether such data exists or not, and to know its content and origin, to verify its accuracy or to request additions, updates, or rectifications.

The subject has the right to request the cancellation, change into anonymous form or blocking of the data that regard him/her, even if pertinent to the scope of data gathering or for the sending of advertising material or direct sales, or the carrying out of market research or for commercial communications.

The subject concerned can do complains to the Authority to guarantee the safety of his/her data.

g) The personal data You provide will be kept at the offices of the Company Marloc S.r.l. headquartered in Località San Martino, 5 - 24060 Foresto Sparso (BG) – Italy.

h) The personal data You provide could be sent outside the European Union in accordance with the article 44 and following Regulation.

Concerning this, it is specified that Marloc S.r.l. can operate exclusively with subjects that have adhered to the “Principles of safe harbour regarding privacy” (Privacy Shield agreement).
